BRUCE TOWNSHIP MONTHLY MEETING JUNE 10,2025

Present were Chairman Becker, Supervisor Gray, Supervisor Mollner, Clerk/Treasurer Eggerth, Don Repp, Jolene Sutton, Nancy and Dwight Tschida, Rick Jones, Randy Craft.

Meeting was called to order at 7:00 p.m. by Chairman Becker.

Pledge: was recited.

Minutes: Minutes of the May meeting were read. Supervisor Gray made a motion to accept the minutes as read, Supervisor Mollner seconded.

Agenda: Supervisor Gray added wood in ditch on 250th St, Chairman Becker culvert on 321st Ave. Supervisor Mollner made a motion to accept the above additions, Supervisor Gray seconded.

Financials: Internet has been down so the financials for May and June will be presented at the June meeting. Supervisor Mollner made a motion to have May and June financials presented in June, Supervisor Gray seconded.

Planning and Zoning: Supervisor Gray had made a site visit to Mehr property on Lake Beauty. Chad Twardowski has a sewer design done, Supervisor Gray could see no problems with setbacks for the new house, a permit can be issued.

Och Property on Lake Beauty wants to split a 20-acre parcel into two ten acre lots. Chairman Becker made a motion to give the ok for this property to be split, if he wants to split more then into two lots, he will need to come back to board and may need a subdivision. He will fill out the land split paperwork and send in with a survey.

Planning and Zoning signs: We need 25 signs, they will be blue and white, they will send us a sample before they are made up.

Website: Website is back up and running. Clerk asked what the Supervisors want on the website. Discussion was held and Chairman Becker made a motion that only the signed minutes ,notice of next meeting , and any important notices will be put on the website. Supervisor Mollner seconded.

Wood in ditch on 250th St. Supervisor Gray had received a call from a landowner that there was a log in the ditch on their property that must have fallen off a truck. Supervisor Gray made a motion to have Dennis Becker cut the log up and haul away the wood. Supervisor Mollner seconded.

Truck in ditch on 315th. Supervisor Gray had received a call from a person who had run into the ditch on 315th, about 100 yards North of 27. He went there and looked at where they had gone in the ditch and there was no damage to the road.

Culvert on 321st Ave. There is a crack in the road, and it is starting to break off and the road going into the water. Chairman Becker had contacted the county to see if that is considered a bridge or a culvert. County told him to fix it. Rocks and boulders will be used; cost will run around \$24000.00. Nancy (the county ditch inspector said it was ok to fix) waiting for DNR approval. Supervisor Mollner made a motion to fix the road as soon as DNR approves, Supervisor Gray seconded.

Ditches: Supervisor Gray made a motion to have Dennis Becker cut the grass along the roads, as necessary. Supervisor Mollner seconded.

Randy Craft: Randy wants to split off 5 acres that his present house sits on. He owns other small parcels along 315th Ave. He owns parcel 04-001571 which is behind these other parcels and runs to highway 27, there is no access on highway 27. He will need to make sure he leaves access to this parcel when he splits the 5 acres off through the remaining 8 acres. To build more homes on his property he will need to do a subdivision. He asked to have this all tabled until he has time to think about how he wants to manage this.

341st Ave.: Jolene Sutton, Don Repp, Mr. & Mrs. Tschida wanted the board to know they do not want anything done with 341st Ave. at this time. There had been discussion earlier in the year about Tschida's using some of Sutton's land to access their property. The board had produced a solution, but the three homeowners do not want trees taken down, etc., Chairman Becker made a motion to table any changes on this road until the landowners bring it back with their idea of a solution. Supervisor Mollner seconded.

Bills: Supervisor Gray made a motion to pay all bills presented. Chairman Becker

Comments: Rick Jones asked about dust control by lake. Discussion on availability of minutes, Chairman Becker said it can be up to two months before minutes are available if there are corrections or additions to the minutes. They must be signed to be legal, and only legal minutes will be available.

Adjourn: Supervisor Mollner made a motion to adjourn, Chairman Becker seconded.
