

BRUCE TOWNSHIP MARCH MEETING

MARCH 12, 2025

Present were Chairman Becker, Supervisor Mollner, Rick Jones, Clerk/Treasurer Eggerth, Mr. Repp.

Pledge :

Minutes: Supervisor Mollner made a motion to accept the minutes as read. Chairman Becker seconded.

Agenda: Chairman Becker made a motion to at the accept agenda as written, Supervisor Mollner seconded.

Repp CUP: Public Hearing had been held on March 11, 2025. Supervisor Mollner made a motion that before this land is split again, it would need to be subdivided. Chairman Becker seconded. CUP was granted.

Rick Jones Mr. Jones had done some work on his shoreland because of erosion. He asked to piggyback this work onto his previous shoreland alternation permit. Chairman Becker said he need to make a new application and get it the ok from the DNR and Todd Soil and Water, bringing that information to a board meeting. Supervisor Mollner seconded.

Kevin Schmitz feedlot: Residences around the feedlot and the Todd County Assessor's Office have been questioning if there are permits for all the buildings he has. Chairman Becker made a motion to have Clerk contact assessor and get the dates the buildings have been added to the tax rolls. Supervisor Mollner seconded.

Cul da sac: Don Repp, Loren Sutton and Dwayne Tschida are asking for board to fix the cul da sac by their property. Loren Sutton claims Tschida driveway is on his property. The clerk will bring the information the township has on that cul da sac to the April meeting.

Matt Jahnke: his driveway needs the culvert replaced and he does not have the funds to do this. The water runs down his driveway and out onto the road, washing the road out. This causes a safety risk for the public. Two ideas have been discussed in the past, one is to cost share between the township and Mr. Jahnke, or we could lift the road up 1 ft. and that would take care of the liability for the township. Chairman Becker made a motion to have Clerk send a certified letter to Mr. Jahnke and invite him to the April meeting.

Culverts: Chairman Becker asked Clerk to bring information from township association and bring to next meeting to discuss a culverts policy for the township.

Upcoming meetings: Todd County Township association meeting is April 1 at Clarissa Ballroom. Long Prairie Fireman's meeting is April 2 at Long Prairie City Hall. Chairman Becker made a motion that any town board member can attend these meetings. Supervisor Mollner seconded.

Gravel Bid: will be discussed at the April meeting, having bids open at the May meeting.

Road Report: Roads are muddy and frost is not out yet. Ross is starting to pull shoulders in.

Bills: Chairman Becker made a motion to pay all bills presented, having Supervisor Mollner sign checks because of Supervisors Grays absence. Supervisor Mollner seconded.

Adjourn: Supervisor Mollner made a motion to adjourn, Chairman Becker seconded.
